### President's Address

This is my third and final annual report as President. It has been a great honour and privilege to have been President of your College and I deeply appreciate the support, encouragement and advice I have received over the past three years. I acknowledge with gratitude the major contribution, commitment and support that Council Officers, Council Members and Fellows have made to The College and to the office of President. 2008 has been an exciting year for The College and I am delighted to announce that the projects referred to in the annual reports of 2006 and 2007 have come to fruition despite the uncertain climate created by consultant contract negotiations, a new Medical Practitioners Act and the formation of the HSE Medical Education Training and Research Committee. The College while always maintaining its focus on its core objectives of education, training and the maintenance of standards of anaesthesia in Ireland has also responded to the additional expectations and demands created by the new political and medical climate. These achievements are a tribute to the commitment of College Officers, Council Members, Fellows and College staff who continue to generously dedicate their time and effort and financial support to enable The College achieve its objectives. I thank you all.

In my report for 2007 I referred to our ambitions for 22 Merrion Square. I am delighted to report that the refurbishment and building programme has begun and will be completed in September 2009. I congratulate our hard working project team under the Chairmanship of Dr William Blunnie for all their work in bringing the concept to fruition. I also thank our Honorary Treasurer, Dr John Loughrey and his committee for their advice and expertise in ensuring The College uses its financial resources wisely and to best effect. The refurbished building and the additional new educational facilities in Denzille Lane will facilitate The College to continue to

fulfil and expand its educational and training roles into the future. We look forward to our Fellows and indeed all anaesthetists continuing their practical support for this project.

The establishment of the Faculty of Pain Medicine by The College is the fulfilment of a long term ambition of The College. It is a sign of the strength and commitment of The College to its Fellows. I congratulate the inaugural Dean Dr David Hill and the members and wish The Faculty every success. The Pain Faculty held its first conferring in November and I welcome the Foundation Pain Fellows to The College.

The formation of the Joint Faculty of Intensive Care Medicine of The College of Anaesthetists, The Royal College of Surgeons in Ireland and The Royal College of Physicians of Ireland is a major and historic event and is very much welcomed. It is the culmination of many years of dedicated hard work and I would like to especially congratulate and thank Drs Brian Marsh and Jeanne Moriarty for their hard work, patience and negotiation skills in ensuring the establishment of the Joint Faculty. I am confident that the new Joint Faculty will go from strength to strength in the future.

#### **Education & Training**

This is the core business of The College. In 2008 in light of increasing demands and expectations it has been necessary to add support to our Dean and the Dean's office. Funding was obtained from the HSE to appoint a Vice-Dean and Dr Eleanor O'Leary has been appointed to this role. The Vice-Dean will undertake the development of competency based training programmes and will also support our CME/CPD and Competence Assurance Committee chaired by Dr Harry Frizelle. As the Medical Practitioners



Act 2007 now requires doctors to participate in competence assurance programmes we are confident that this crucial appointment will facilitate anaesthetists to comply with the requirements of the Medical Practitioners' Act 2007. Our web site www.anaesthesia.ie enables Fellows to maintain their CME record on-line. The provision of journals both online and in hard copy is an expansion of our services to Fellows. It is our expectation that additional educational material will be added to the site over time.

Dr Jeremy Smith Chairs The College committee responsible for the development of simulation for anaesthesia and medical training. In light of the development of simulator centers on two sites; UCC and St. James Hospital, The College is eager to examine how simulators may best be incorporated into Irish medical and anaesthesia training programmes. As part of this commitment The College has obtained HSE funding to enable the appointment of Dr Crina Burlacu to advise and assist in this process.

The Hospital Inspection Committee chaired by Dr Philip Hawthorne continues its important work auditing, supporting and developing the training standards of our hospitals. The inspection process is assuming greater importance in the new medical climate.

Dr Katrina O'Sullivan chairs the Credentials Committee. This most important committee amongst other responsibilities ensures that the highest standards are maintained for admission to the register of medical specialists. I deeply appreciate the difficult but valuable work Dr Katrina O'Sullivan does on behalf of The College.

Dr David Mannion has taken over as chair of the Training Committee having been its Honorary Secretary. I appreciate Dr David Mannion's commitment and dedication.

Dr Deirdre McCoy in her first year on Council has assumed responsibility for the Final Fellowship Course and for the MSc in Anaesthesia and recently has been appointed Honorary Secretary of the Training Committee; I thank her for this support.

The Autumn College Lecture was delivered by Dr Michael Mc Brien in conjunction with the South of Ireland meeting in Killarney and our Winter College Lecturer was Dr Jennifer Hunter. Our Gilmartin Lecture was delivered by Dr Archie Brain. All proved to be outstanding choices and contributed considerably to the educational meetings held in association with the lectures. My sincerest thanks to Dr Joseph Tracey, his committee members and all who dedicated so much time, effort and commitment to organizing and running the educational meetings.

#### **Examinations**

Our examinations continue to develop and evolve. A special thanks to the Chair of our Examinations Committee Dr. Ellen O'Sullivan for managing these changes. We also thank Dr. Ken Lowry and Dr. Kevin Carson, Chairs of the Primary and Final Examinations respectively. Dr Philip Hawthorne continues his work on behalf of the Examinations Committee and the computerisation of the MCQ bank. We also sincerely thank our examiners who contribute so much to the success of the examinations. The College also hosts the Pain examination chaired by Dr Donal Harney and the Board of Intensive Care Medicine examination chaired by Dr Brian Marsh. The College also facilitates the European Board of Intensive Care examination. Unfortunately, due to the recent changes in the

Medical Practitioners Act 2007 relating to education sponsorship the Overseas Qualify Examination (OQE) examination previously held annually in Oman is not being held in 2009.

#### **Deans Office**

Our Dean Dr Ian Surgeon has been and continues to be a stalwart in The College since its inception. His vision, attention to detail and communication skills have been a significant contribution to the success of the Dean's office and of The College. The challenges posed in 2008 were met with efficiently and professionally, Anaesthesia in Ireland is very fortunate to have him as Dean. In 2008 Dr Surgeon delivered a revamped IT system for The College which is flexible and incorporates all the features The College requires to deliver its services to its Fellows. I thank Dr Surgeon for his continued commitment to The College and am delighted that he is being joined by a Vice-Dean to continue to develop and expand the programmes of education and training required in the new environment.

#### Management and Administration

2008 was a busy and eventful year for our management and administrative staff. The building project required moving The College off site to 12 Duke Lane. This was achieved with military efficiency and with minimal disruption to Fellows. I cannot thank enough all our staff who made this possible. I take this opportunity to thank individually our staff, Ms Margaret Jenkinson our Finance Officer who looks after all our financial matters so well, Ms Marguerite Harvey and

Ruth Flaherty in examinations who with good cheer efficiently organize all our examinations. Our thanks to Ms Maria Golden and Orla Doran in the Education and Training Department for the organisation of training, education courses and matters relating to trainees. I thank Ms Mary Malone who has been a major support to me for the past year. Our management and administration team, professionally led by our CEO and Registrar Dr Orlaith McCaul have met most efficiently the many challenges posed during the year. We sincerely thank them and look forward to their continued involvement in and contribution to the future development of The College.

#### **Projects**

The College has significantly progressed many of the aims and objectives of Council in 2008. I have already referred to our building programme and the establishment of both the Faculty of Pain and Joint Faculty of Intensive Care Medicine. 2008 has also seen the development of and appointment to both the post of Vice-Dean and the post for Simulation Development.

Our educational project in Malawi for Anaesthetic Officers delivered over the past four years and focusing on obstetrics and trauma concluded with the final programme being delivered in January 2009 under the leadership of Dr Jeanne Moriarty.

In 2008 The College obtained substantial funding from Irish Aid to develop and support a major three year anaesthetic training programme in Malawi. This programme will build on the experience of the previous five years for clinical officers and the recruitment of doctors to a funded and structured anaesthetic training programme is part of this development. The first event



of this new programme occurred in January 2009 in Blantyre. In addition to Irish Aid The College is joined in partnership by the Ministry of Health in Malawi and the University Medical School in Blantyre. I congratulate Prof. Anthony Cunningham and Dr Orlaith McCaul for their dedication and devotion to this most worthwhile charitable project.

The College continues to be an active participant and contributor to the Forum of Irish Post-Graduate Training Bodies. The Forum brings together the Presidents of the Postgraduate Medical Colleges in Ireland and the Deans of Medical Faculties to implement policies of mutual benefit and interest and to interact with HSE, Medical Council, DOHC and others to advance medical education and training in Ireland.

The reports of the various Committees of College will give much greater detail on individual College Committee activities and their achievements. On behalf of Fellows and on my own behalf I acknowledge with gratitude the major contribution that each and every chair, member of committees and fellows individually and collectively has made to the development of The College in 2008.

#### **Awards**

The Council award 2008 went to Prof Padraic Keane Past, Dean of the Faculty of Anaesthesia and retired Consultant Anaesthetist, University College Hospital Galway. Our honorary conferees brought together the Presidents of the three Colleges of the NUI. Professor lognáid O' Mhuircheartaigh, President of UCG, Professor Michael Murphy, President of UCC and Professor Hugh Brady, President of UCD. The NUI has supported anaesthesia by establishing Professorial Chairs of Anaesthesia in its respective Colleges.

My sincerest thanks to my Vice President Dr Seán McDevitt, my Honorary Secretary Dr Brian Marsh, Council Officers and Council Members, Committee Chairs, Members of Committees and all who have contributed to the educational courses, examinations and the other important activities and events undertaken by The College. Your contributions are acknowledged, greatly valued and very much appreciated. I also thank our friends in industry who continue to support anaesthesia education in Ireland.

The challenges posed to The College in 2008 will continue in 2009. However, I am confident that with the structures presently in place and with vision and collective action The College will continue to develop and achieve its objectives. Your continued support and the support of all the Fellows of The College will be crucial. Again I thank everyone who has helped and supported me and made my Presidency such a pleasure and joy. I also thank my colleagues in the Cork University Department of Anaesthesia who facilitated my absences from the department and the management team at CUH who value and appreciate the importance of The College of Anaesthesia. A special thanks to Anne and my family for all their support, patience and encouragement over the past three years.

### CEO's Report

#### **The College Objectives**

The objectives of The College as set out in the Memorandum and Articles of Association are as follows:

- To train and educate medical graduates to maintain the highest possible standards of professional competence in the practice of anaesthesia, pain management, intensive care medicine and related subjects for the protection and benefit of the public;
- To further postgraduate instruction and training in anaesthesia, pain management, intensive care medicine and related subjects both in Ireland and overseas;
- To advance, promote and carry on study and research into anaesthesia, pain management, intensive care medicine and related subjects and to disseminate the useful results of any such research and to provide expert advice to relevant statutory bodies;
- To educate the general public in all matters relating to anaesthesia, pain management, intensive care medicine and related subjects.

## Governance and Management

We are governed by a Council elected by the fellows of The College. The Council also co-opts members as required. The Council is currently made up of 18 members and one co-opted member. All members of the Council act in an entirely voluntary capacity. It meets six times a year to discuss and approve recommendations of the twelve Committees of Council. The day to day management of The College is

run through the office of the Chief Executive/ Registrar with the support of an Executive Management Team made up of The President, Vice President, Honorary Secretary and Honorary Treasurer. The Postgraduate Dean with the support of the newly appointed Vice Dean are responsible for the education and training activities of The College.

#### Achievements and Performance

2008 was an exceptional year for The College. To facilitate the development of The College's premises in Merrion Square, The College's administrative offices were temporarily moved to Duke Lane. This was not without its challenges. I would like to take this opportunity to express my sincere thanks to all of the staff not only for all their hard work throughout the year but in particular for the significant efforts that were made to ensure that the move was as efficient as possible.

Other significant events for The College in 2008 included the establishment of the Pain Faculty and of the Joint Faculty of Intensive Care Medicine. We were also delighted to welcome to the staff Dr Eleanor O'Leary who has been appointed Vice Dean. We received a grant from Irish Aid to support our humanitarian commitments in Malawi. In addition to our core funding from the now dissolved Post Graduate Medical and Dental Board, we secured funding from the HSE-METR for a variety of projects. This funding has enabled us to continue to develop our work on Competence Assurance and Simulated Learning. Also in 2008, after several years of development, we launched our new database. This will streamline trainee and examination administration along with our register of Fellows.



Whilst the majority of our fellows interact with us on matters related to training and examinations, this is only a part of what we do. We conduct hospital inspections to ensure that standards of education and training are appropriate. We provide career advice and mentoring to trainees and fellows. Through the Quality and Safety Advisory Committee we deal with requests for professional guidance from departments or individuals experiencing difficulties. We interact on behalf of our fellows with Government Bodies such as the HSE and HIQA and through our membership of the Forum of Post-Graduate Training Bodies we influence and advocate on behalf of the profession. We keep proper accounting records and safeguard the assets of The College. We can only do all of this because of the dedication, loyalty, energy of the staff and Council. It is with sincerity that I wish to thank everyone for their imagination, determination and hard work. Finally, my thanks to the Fellows of The College who remain in Good Standing; it is because of your subscriptions that we achieve our objectives and can continue to develop Anaesthesia, Intensive Care and Pain Medicine.

### Postgraduate Dean's Report

A majority of the activity of the Postgraduate Dean's Office intersects with the work of the Training, Credentials, Education and Examination committees, all of which have reported elsewhere. This activity is primarily related to the management of trainee rotations and assessments. Beyond this work, there have been other significant developments in 2008 that will have ramifications for the future structure and conduct of postgraduate training and education.

## **Medical Practitioners Act**

The new Medical Practitioners Act gives a role to the Medical Council to accredit Postgraduate Training Bodies and their training programmes, both pre-CST, and post-CST in the continuing education arena. The emphasis in this accreditation will be on competence assessment and assurance and, in pre-CST training, on posts that are part of formal Training Body-managed programmes. Furthermore, any doctor practicing in Ireland, who is not a trainee, will have to engage in a competence assurance process to the requirements of the Medical Council.

## **National Audit** of NCHD Posts

The National Audit of NCHD posts, completed in Spring 2008, has provided for the first time an overview of NCHD posts in all specialties. The data available has highlighted a number of issues:

- The current and future role of the registrar grade as a training post;
- The structured progression of doctors through the

postgraduate training pathway;

- The number of posts not accredited for training;
- The registration status of doctors with an approved postgraduate training body;
- The future management of stand-alone training posts and non-accredited posts.

Arising from the recommendations of this audit, a formal National Database of NCHD posts and their occupants is currently being set up, and a stakeholder group is to be formed to manage and implement change in postgraduate training structures. I will represent the Forum of Postgraduate Training Bodies and The College in both these processes.

In response to these developments, The College has made significant moves in 2008 to help meet these challenges:

#### **New Appointments**

- Dr Eleanor O'Leary has been appointed Vice Dean and has taken up duty. She will initially concentrate on how The College is going to implement competencebased curricula and assessment using internationally validated methods, for pre and post CST education and training. This is a big task, and is being supported by funding from the HSE. I am confident that Dr O'Leary will bring a no-nonsense approach to this task, and will establish realistic and achievable goals.
- Dr Crina Burlacu has been appointed as Director of Medical Simulation. She is tasked with the development of skills lab based training programmes within anaesthesia training, as well as more generic programmes for a wider audience. She will examine the capabilities of existing and incipient simulation centres throughout Ireland with a view



to providing centrally coordinated but regionally based programmes for anaesthesia. This is of course interrelated to the development of competence assurance programmes.

## **New Administration System**

The College's new administration system was completed on time in 2008 and came into use in July. This centralises all college tasks previously managed on different systems. Thus management of exams, training rotations, fees and subscriptions and courses and events now use a common data source. This will greatly simplify keeping data current and consistent and should remove many sources of inaccuracy. The system is comprehensive yet flexible and is amenable to further development. It will allow The College to accommodate structural changes in postgraduate training, and the implementation and tracking of competency assurance processes beyond the CME points recording system that is currently available. HSE funding for this project was not granted in 2008, however we have reapplied to the HSE for retrospective funding support for this system as well as prospective funding for further development in 2009. This will concentrate on increasing data inputs and outputs via our website, particularly information to and from College Tutors.

## National Training Committee Report

The College of Anaesthetists has responsibility for training in Anaesthesia in Ireland. A Certificate of Specialist Training (CST) is awarded to those trainees who complete their training under its supervision. The first two years are spent in a Basic Specialist Training (BST) programmes organised by a Regional Training Programme. There are currently four such programmes - Eastern, Western, Southern and North Western. The Specialist Registrar (SpR) programme is organised on a national basis and trainees may rotate to different hospitals around the country. Entry to this programme is by competitive interview and lasts for five years. A maximum of one year's accredited leave may be taken during this period to work either abroad or in another speciality, or to engage in full time research. Of the final two years at SpR 4/5 eighteen months must be completed in Ireland.

The College's Temporary SpR 4/5 Scheme enables doctors to complete training, either for eligibility for inclusion on the Specialist Register and or for award of CST. This programme is designed for trainees who may already have many years training in Anaesthesia but may need further training at SpR 4/5 level.

Interviews are usually held twice yearly for the SpR and Temporary 4/5 posts.

The Training Committee meets five times annually and reports to The College Council. The Committee includes College Council members, and representatives from the Regional Training programmes, Royal College of Anaesthetists and the Anaesthetist in Training Group.



Currently training is time based and, at seven years, is one of the longest training programmes in Europe. In the near future, the emphasis will move to competency based training with regular competency assessments on all trainees. The College is currently in the process of implementing a competency based model of training and assessment.

The Temporary Registration Assessment Scheme (TRAS) exemption scheme (previously Section 7.6) was discontinued by the Medical Council in 2008. Doctors applying for temporary registration are no longer exempt from the TRAS by virtue of entry onto a recognised postgraduate training programme. Dr Carlos McDowell administered this scheme for the duration of the programme and The College would like to acknowledge her invaluable input over the last number of years.

The European Working Time Directive (EWTD) pilot programmes were completed in 2008. The National Implementation Group (NIG) published a final report in December 2008. Non consultant hospital doctors (NCHDs) in Ireland today are not compliant with the terms of the EWTD. This will be even more evident once the 48-hour week comes into effect in August 2009. The College would like to thank Dr Catherine Motherway for her enormous contribution to the NIG on behalf of The College.

## Master of Science in Medical Professionalism (Anaesthesia)

The Master in Science (Anaesthesia) was initially founded in 2002. This was restructured and renamed, Master of Science in Medical Professionalism

(Anaesthesia) in 2007. It is approved by The Royal College of Surgeons in Ireland (RCSI) and the Senate of the National University of Ireland.

The course was initially offered part time over two - five years and all modules were compulsory. However, this evolved in 2007 to the present format. Now a core of compulsory modules exists namely Professionalism in Practice, Medical Education, and Legal Medicine and Risk Management with choice existing for another two modules. The modules are provided by a combination of distance e-learning, didactic lectures and a large amount of self-directed learning. The candidates who have completed the course unanimously testify to the high standard that is set by the course tutors and the significant commitment that is required.

A number of consultants completed a module during the last two years and all said that they found it extremely useful in their day to day working lives. This structured education is allocated CME points reflecting the education/learning hours devoted to such a module. Enrolment for the next course will commence in September 2009.

To date twelve candidates have graduated with the MSc – many of them with honours. It is expected that six will complete the programme in 2009.

The past year has been a busy one for the Education Committee with a large number of courses, workshops, lectures, competitions and the Irish Congress of Anaesthesia. The Committee met five times during the year on the 6th February, 4th April, 27th June, 12th September and 10th December and reported back to the Council and the President.

#### **College Courses**

This year The College held two Introduction to Anaesthesia courses. Both were held in The College on the 7th & 8th of February and the 19th & 20th of June. The course was run by the Postgraduate Dean, Dr Ian Surgeon.

The Final Revision Course was run by Dr Kevin Carson from the 21st – 25th January. The course proved very successful and received positive feedback from the participants. A Pain Revision course was held on the 22nd & 23rd May. This was organized by Dr David Hill. The Primary Revision Course was scheduled to run on the 8th – 11th of September but was cancelled due to a low response.

### **Delaney Medal Presentation**

The Delaney Medal presentation took place in the Radisson Hotel on Thursday 1st March. The adjudicators were Dr Aiden Synott (Beaumont) and Dr Harry Frizelle (Mater). Fannin sponsored the reception which was held afterwards in the Raddison Hotel. The winning presentation was Dr Dominic Hegarty with a presentation entitled "Anaesthetic agents differentially affect intracellular calcium homeostasis in both resting and stimulated neuronal cells".

#### **Abbott Scholarship**

The Abbott Scholarship in Anaesthetic Research was held on Friday 2nd March. Abbott Laboratories once again provided €10,000 for a scholarship to support original research by an Irish anaesthetist. The judges were Prof Howard Fee (Belfast) and Prof Anthony Cunningham (Dublin). The presentations were held in the Dr Wallace Abbott Seminar Room at The College of Anaesthetists. The winner was Dr Tanya O'Neill with a presentation entitled "Post-Operative Cognitive Dysfunction: The Contribution of General Anaesthetic Agents to its Aetiology and the Role cognition enhancing drug therapies in mitigating its development".

## **Irish Congress of Anaesthesia (ICA)**

This was held on 15th & 16th May in the O'Reilly Hall, Belfield Campus, UCD, Dublin 4. The meeting covered a broad range of topics and also included



sessions devoted to neuroanaesthesia, regional anaesthesia, chronic pain therapy and the inaugural session on the history of anaesthesia. The faculty included speakers from Belgium, USA, Israel, New Zealand and the United Kingdom as well as a number from Ireland. The Anaesthetists in Training in Ireland also ran a session.

The Gilmartin Lecture on the Thursday evening was given by Dr Archie Brain, and was entitled "LMA" this was followed by the Annual Dinner of The College of Anaesthetists, which was held in the Four Seasons Hotel.

#### **Core Topics Day**

The Core Topics Day meeting was held in the Waterfront Hall in Belfast on 23rd September. This meeting is a joint effort between the RCA and The College of Anaesthetists. It was organized by Prof Howard Fee. The College provided two speakers, namely Dr Dara Breslin with a talk entitled "Regional Anaesthesia - is it better for our patients? and Dr Leo Kevin with a talk entitled "Coronary Stents, Antiplatelet Agents and the Surgical Patient".

#### **Autumn College Lecture**

The Autumn College Lecture was given as part of the South of Ireland Association of Anaesthetists meeting on 26th and 27th September in Malton Hotel, Killarney. This lecture was given by Dr Michael McBrien (Belfast).

#### **Winter College Lecture**

The GSK Medal Presentations and the Winter College Lecture were held on the 21st of November in the Gresham Hotel. The Winter College Lecture was given by Dr Jennifer Hunter from Liverpool and was entitled "A Novel Approach to Reversal"

## Hospital Inspections Report

Hospital Inspections are carried out under the remit of the Training Committee. Since 'training' is not just about examinations and theory but involves hands on clinical practice, the evaluation of the training environment is a vital part of a Training Body's work.

Hospitals which The College has recognised for training are inspected on a five yearly cycle, though other inspections may take place in advance of the next scheduled on for various reasons — perhaps an increase in the number of posts or conversion from a BST accredited post to an SpR post.

The inspection process starts with notification to the anaesthesia department that an inspection is due. A questionnaire is sent which, when returned to The College, gives the inspectors background information about workload and facilities. This detailed document forms the basis for the actual inspection. (There has been some inter-collegiate discussion about the possibility of having a common, general inspection process shared by several colleges in an effort to reduce colleges' workload and inconvenience to hospitals. This is still at discussion stage.)

After agreeing a date the inspection itself is carried out by, usually, two council members with either the Postgraduate Dean or Registrar and a member of College administrative staff. Much of the inspection is straightforward confirmation of the data provided on the questionnaire; but the physical inspection also gives the hospital consultants opportunity to voice concerns and the trainees opportunity to praise or criticise the department in confidence.

Department should see the inspection process as a training resource; on the one hand The College has a mandate to maintain standards of training and will, rightly, highlight areas where departments are below par. On the other hand, departments with resource or staffing difficulties can look to The College for support in their endeavors to raise standards. Most departments find the inspection stressful but in the majority of cases are well prepared. It is worth noting that details of the process can be found on The College website so there should be no surprises on the day.

In 2008 there were ten scheduled inspections carried out. This is an onerous task involving time off work, travelling and preparation time for the inspectors. I would like to thank those who have volunteered, those who have been coerced and those who don't yet know they've volunteered for giving up their time.

## **Credentials Committee Report**

#### **Members**

This is my second report as Chairperson of the Credentials Committee since I took over the Chair from Dr Rory Dwyer in June 2007.

The main work of the Credentials Committee relates to assessment of anaesthesia training and experience for the purposes of inclusion in the Register of Medical Specialists (RMS) — anaesthesia and advising on further training if required. The number of applicants has increased with the establishment of the new Register of Medical Practitioners in March 2009. Prior to March 2009 The Credentials Committee also assessed applicants for Full registration on the Medical Register.

The new Register of Medical Practitioners has four divisions:

- trainee specialist
- specialist
- general
- visiting EEA practitioner providing services on a temporary or occasional basis.

Registration in the Specialist Division – Anaesthesia indicates a doctor is fully trained and accredited in the Speciality of Anaesthesia.

The Medical Council refers applications for inclusion in

the RMS – Anaesthesia to The College of Anaesthetists for advice on eligibility. If an applicant has not completed the SpR training programme in Ireland, the Credentials Committee seeks to establish whether the training and experience of the applicant are equivalent to the standard of a holder of a Certificate of Specialist Training issued by The College of Anaesthetists. This process requires detailed documentation and confirmation of all anaesthesia training and experience achieved by the applicant. The applicant's training and experience is evaluated with reference to the Specialist Registrar Competency Assessments contained in The College of Anaesthetists Training Portfolio 2006. Following this comprehensive process The College then advises the Medical Council as to the inclusion of the applicant on the RMS. The College levies a fee for this process. The fee is currently set at €1000. The Medical Council makes the final decision on each applicant's eligibility for Specialist registration.

If an applicant has not achieved all essential SpR competencies to the level of wholly independent practice as an anaesthetist, The College advises on how to remedy these deficiencies for the purpose of inclusion on the RMS. This advice will likely be in the form of eligibility to apply for a period of further training at SpR 4/5 level.

## **Irish Board of Intensive Care Medicine Report**

The Board met on five occasions. The main objectives of the Board in 2008 were the establishment of the Joint Faculty of Intensive Care Medicine of Ireland under the aegis of The College of Anaesthetists of Ireland, The Royal College of Physicians of Ireland, The Royal College of Surgeons in Ireland, and the Intensive Care Society of Ireland and recognition of speciality status by the Irish medical Council. The Conjoint Faculty of Intensive Care Medicine was formally established on 16th December 2008 at a meeting attended by the Presidents of The College of Anaesthetists of Ireland, The Royal College of Physicians of Ireland, The Royal College of Surgeons in Ireland, the Intensive Care Society of Ireland, and the members of the IBICM. The Board acknowledges the support of the Presidents of The College of Anaesthetists, The College of Physicians and The College of Surgeons and the assistance and expertise of Mr Fintan Foy of the RCSI and Mr Leo Kearns of the RCPI in progressing the development of the Joint Faculty of Intensive Care Medicine.

Diplomats of the IBICM and consultants practising Intensive Care Medicine will be invited to join the Joint Faculty in 2009 in accordance with the ad eundem regulations. The IBICM will continue in tandem with the establishment of a fully elected Faculty Board over the next three years.

The application for specialty status for Intensive Care Medicine to the Irish Medical Council has been delayed by the implementation of the new Medical Practitioners Act and the establishment of a new Medical Council. However, The Board remains confident that this issue will be addressed in 2009 and continues to pursue this vigorously.

Early in 2009 the faculty will be working towards recruiting ordinary fellows who have obtained the pain diploma exam, and will submit a dissertation for admission as a fellow. The faculty will also be working towards an alternative pathway to allow Pain Medicine Consultants in the UK, with Anaesthetic Fellowships from our College to gain admission to The Faculty.

### Academic Anaesthesia Committee Report

The Academic Committee, which includes memberships from the Academic Departments of Anaesthesia of University College Dublin, Trinity College Dublin, Royal College of Surgeons in Ireland, University College Cork, NUI Galway, University of Limerick and Queen's University of Belfast, was established in 2007 to promote anaesthesia input into national education and research programmes.

The Committee met in May, September and November 2008.

The Agenda for the Academic Committee included:

#### NUI Application – Independent Degree Conferring Status for College of Anaesthetists

The College is in discussion with the National University of Ireland (NUI) with a view to becoming a "recognised College" of the NUI.

## Input into the National Committee on Medical Education and Training (NCMET)

The National Committee on Medical Education and Training was established by the Department of Health and Children and the Department of Education and Science in February 2007. The Committee reports to the Inter-departmental Steering Group of Medical Education and Training.

The National Committee established three subcommittees:

#### (a) Undergraduate

Chairman: Prof. Anthony Cunningham

#### (b) Intern

Chairman: Ms. Ailish McGovern

#### (c) Postgraduate

Chairman: Prof. Dermot Kelleher, Trinity College.

The College is represented on the Committee by Dr. Ellen O'Sullivan.

The aim of the Committee is to oversee and contribute to an integrated implementation of government policy on medical education and training arising from the Buttimer and Fottrell Reports.

## **Academic Clinician Posts**

The Academic Committee received reports concerning Academic Clinician Posts through the National Medical Education and Training Committee and the Forum of Irish Postgraduate Training Bodies.

Arising from a recommendation in the Fottrell Report "Medical Education in Ireland; A New Direction 2006" an additional twenty-five academic clinician posts were proposed. These posts were jointly funded by the HSE Medical Education Training and Research (METR) Unit and the Higher Education Authority (HEA).

Specialties in these new academic clinician posts included Professor of Anaesthesia in Trinity College Dublin (subsequently eliminated) and Senior Lecturer post in NUI Galway. However, due to economic consideration and budget constraints only four posts have been funded and filled, with four posts allocated to the University of Limerick in 2009.

## **Dr. Richard Steevens Scholarship Award**

The HSE METR group awarded eight scholarships and three bursaries under the Dr. Richard Steevens Scholarship which was intended for specialist registrars who have demonstrated considerable potential or proven track record for achievement by funding a period of up to twelve months training abroad.

The training programme is aimed at novel areas of medicine and patient care. These have included maternal-foetal health, endovascular surgery, stroke medicine, palliative care, inflammatory muscle diseases. To date The College has been unsuccessful in achieving funding through this scheme.

## **METR – Revenue Grants for Medical Training**

The Committee considered The College's allocation of €30,000 for projects in 2008 including e-logbooks, on-line education, clinical governance, clinical skills development, career seminars, teaching and mentoring courses for trainers and generic skill course for trainees such as communication and interview skills.

#### **Capital Developments**

The Committee was briefed on the outcome of the audit conducted by the HSE on Medical Education and Training facilities in clinical sites undertaken by the HSE and METR capital team.

An audit of education facilities was also carried out by the HEA in medical school sites. These audits recommended the development of a multi-annual capital investment programme in education infrastructure on clinical and academic sites.

The HSE and HEA have jointly funded the start-up costs of a multi-disciplinary simulator based education and training centres -

- ASSET Centre Cork.
- St. James's Hospital, Dublin followed this HSE capital development programme.



#### National SHO/Registrar Audit

The Forum of Higher Postgraduate Training Bodies, with The College of Anaesthetists input, conducted an audit of 3,417 posts with a collection of data from individual training bodies, hospital medical manpower managers and through interviews with trainees.

The audit identified an alarming number of stand alone, non-rotation, unrecognized posts with suggestions for the requirement for re-training and re-entry schemes for doctors in long-term non- training, service posts.

Dr Ian Surgeon, Postgraduate Dean, will represent The College on a National NCHD Database Committee.

A Change Implementation Group, chaired by the HSE, with representatives of the Postgraduate Forum, is being established to address the deficiencies highlighted in the report.

### Honorary Treasurer's Report

This is my third report as Honorary Treasurer and Chairman of The Finance and General Purpose Committee. The Finance Committee of The College meets at least quarterly and its brief is to ensure appropriate accounting practices are in place, to ensure that The College has sufficient funds to run its activities, and to ensure that College programmes run within budget. The Committee, whose members are listed above, reports to Council, who direct the financial strategies and methodologies of The College. The summarized accounts are included within the annual report and detailed financial statements which are submitted to the Companies Office are available from The College to all Fellows on request. The annual audit of the financial statements, performed by OCMC (registered auditors) is in accordance with standards issued by the Auditing Practices Board.

I am very pleased to report that The College has had a successful financial year in 2008. This is due in no small part to the contributions and goodwill of Fellows and examiners. In anticipation of the capital development at 22 Merrion Square, College examiners who are Fellows were asked to further contribute by foregoing the fees received for participating as examiners. The College is very grateful for the effective contributions from all those who agreed. The College income from Fellows subscriptions has also increased by over 35% on the 2007 figure and in the coming years, this income

category will be of vital importance as expenditure will rise and income from other categories is expected to decline. Increasing use of the Direct Debit facility for subscriptions will assist The College greatly in ensuring all Fellows are in good standing. Overall income has increased by 4.7% on the 2007 figure.

Other income categories on which The College is dependant are grant aid from the Postgraduate Medical and Dental Board, and surplus from College examinations and meetings. The functions of the Postgraduate Medical and Dental board and funding for Training and Education will be through the HSE Medical Education and Training division from 2009 onwards. Some direct funding via the HSE for defined projects has continued through 2008 following submissions by The College. These projects are considered along with those of the other Postgraduate Training bodies, and the emphasis has been toward projects which may have cross-specialty applicability. The College was also successful in receiving funds from Irish Aid for the provision of overseas education in anaesthesia in Malawi. This project will run over a 3 year period and will require a financial outlay from The College of €50,000 in the first year.

Our overall expenditure has decreased by 4.9 % on the 2007 figure. This trend is likely to reverse in 2009 due to the requirement to move The College staff and courses off-site while works to The College building take place. The contracted cost of the Capital Development Project at 22 Merrion Square, which will incorporate facilities for on-site education and training activities, is 3.9 million euro. The additional fees and VAT will bring the total cost closer to €5 million. However, the availability of these facilities going forward into 2010 and beyond will enable The College to reduce expenditure by holding more of its activities on-site. It may also enhance income from rental to appropriate



external agencies. The College has accepted terms of a mortgage from AIB to fund the project, having cleared the previous mortgage on the premises in 2006. Fundraising by way of donations from both Fellows and supporters of The College will defray the long term cost of this ambitious development and I would urge all to consider supporting The College and the specialty in this way.

I am sincerely grateful to Margaret Jenkinson, the Finance officer of The College for her dedication, innovation and expertise throughout the year. We have recently added Niamh O'Connor as an assistant to the Finance Office and welcome her to the staff. I would like to thank the other members of the Finance and General Purpose Committee for their commitment, interest and guidance during the year.





# **International Education and Training Foundation Report**

## Joint College of Anaesthetists of Ireland / Irish Aid Malawi Project

Malawi in general, including the Thyolo and Chiradzulu districts, has alarming maternal and perinatal mortality and trauma outcome data. First responding staff at the district hospitals lack the expertise in the assessment and management of the critically ill obstetric and trauma patient.

The College of Anaesthetists received €480,000 funding for a three year education and training programme based in Malawi in July 2008. The College will contribute €120,000 matching funds from its five year fundraising activities to augment the Irish Aid contribution.

The project is appropriate and timely, bearing in mind that the high maternal and perinatal mortality and the ongoing epidemic of AIDS/HIV and trauma in sub-Saharan Africa but particularly in Malawi where these indices are among the worst in the world.

### **Fundraising 2008**

The College raised almost €25,000 from two fundraising events for the Malawi project in 2008.



# Three Year Education and Training Programme

The College of Anaesthetists of Ireland will establish and support a project in the Queen Elizabeth Medical Centre, Blantyre and Kmuzu Central Hospital Lilongwe to develop a group of clinical officer and nurse trainers skilled in assessment, resuscitation and management of mothers and trauma victims in Thyolo and Chiradzulu Hospitals and nearby district.

The funding proposal features four components:

Capacity building within the Department of Anaesthesia, Queen Elizabeth Medical Centre and The College of Medicine Blantyre to develop leadership in anaesthesia in Malawi.

The Irish Aid commitment envisages the establishment of a committed Joint Faculty, co-ordinated by The College of Anaesthetists of Ireland and The College of Medicine Blantyre for a period of three years.

# Masters in Medical Education (M.Ed)

Partnership and collaboration with The College of Medicine, Blantyre, to launch and sustain a Masters in Medical Education (M.Ed.) degree programme for four designated Malawi medical graduates to undertake 4



years postgraduate education and training in Malawi and South Africa to provide leadership for the specialty in Malawi.

Development of a trauma and obstetric emergencies training programme based in the Queen Elizabeth Medical Centre Blantyre with monitoring, evaluation and audit to measure impact of training activity in Thyolo and Chinadzulu Hospitals.

This proposal aims to produce practitioners who are competent to follow best practice in the assessment and management, including resuscitation and transfer, of maternal and trauma emergencies in a variety of settings.

In addition to produce instructors who will replicate the training programme, with modifications, for impact at health centre and village level. This would imply ongoing training of healthcare staff and traditional birth attendants by trained instructors.

This programme is critically dependent on the appointment of a Project Manager.

The Irish Aid proposal specified that the Project Manager would be medically qualified with an extensive clinical and educational experience with provision of obstetric and trauma care in the developing world for a three year programme.

# **Project Group Report**

### **Members**

The Project Group was established by Council to design and complete the refurbishment of No 22, utilise the area immediately behind the main building and create the Denzille Lane end of site as a multifunctional entity to best comply with the requirements of College.

### **Project Group Objective**

The primary requirement in any development is good design and with this in mind a competition was agreed for which six firms submitted design concepts. The companies involved undertook this process on a pro-bono basis; the CEO and the Chairman undertook briefing of each firm over a three-day period. College employees, members of Committees and Council made a very positive contributory role. Special emphasis was placed on architectural conservation with consultation with the Irish Georgian Society (www.igs.ie) throughout. The design of Roisin Hanley Architects was accepted by College Council. A competitive tendering process followed which awarded the contract to Clancy Construction (www. clancyconstruction.ie).

Contractors moved on site August 2008 with an expected return to Merrion Square by September 2009 by which time no 22 will be fully refurbished. Some month's later The College will take the remainder of new structures in charge.

## **Basement / Lecture Theatre**

The basement area was fully "exposed" with major reinforcement of the structure undertaken. This involved "stitching" the main front wall to the sidewalls, steel and concrete supports for the ground floor, and creation of an 85 sq metre area as a reception, kitchen and cloakroom to accommodate all attendees in the lecture theatre. Between this "drinks / exhibition area" is an enclosed 45 sq metre area courtyard.





Access from the Square to the basement self contained facility will be much safer by re-aligning granite steps; access to the upper building is improved by widening the stairwell. Toilet numbers were designed into the scheme to meet the needs of a "full" house. Catering will allow a sit down capacity for 50 or 135 attendees buffet style. The lecture theatre will have seating capacity for one hundred and thirty-eight, advanced audio-visual equipment, category 6 cabling and electrical connection for each two seats. Voting and/ or keyed MCQ style pads will be installed. Wheel chair access will be from Denzille Lane.

## **Main Building**

The front façade of the building has been beautifully restored such that the prior very obvious difference in brick shading has been re-blended into a visual single unit. The front entrance is restored to allow an impact with tiling, colour scheme and surface finish to emphasise the traditional Georgian features. The reception area will be in the front room and allow a positive and traditional welcome for Fellows and

attendees at The College. Throughout the building password controlled wireless broadband connection will be available for all staff, trainees and Fellows. Recently installed recessed lighting has been removed; ceilings with Georgian features are being restored. A number of fireplaces of appropriate period will be installed. Refurbishment has involved removal of partitions, kitchen and toilet areas from the top floor. All areas are now fully insulated with under floor heating; floorboards were lifted, joists were made more secure with full length support added, which in the process allowed floors to be levelled. A philosophy of a "green" concept was applied where possible.

Council has engaged with the secretariat and senior management to utilise the building in a fashion that will both integrate staff and Fellows and allow multifunctional use. The Faculties of Pain Medicine and Intensive Care Medicine will have space allocated to meet their requirements. Staff facilities by way of common room / kitchen have been placed in the return which will bring an atmosphere of calm and relaxation. Antiquity has been retained where possible e.g. the roof window on the upper floor of the Return.



### **Denzille Lane**

The Denzille Lane building is unusual in that services are placed in the basement, an area that will also accommodate the Simulator Training Unit. Dr Crina Burlacu has been appointed Director and has provided timely advice. This four-storey building will be serviced by a 10-person lift. The first and second floors will be open plan of 98 sq metres each. The "roof" will have a large mostly glass structure with a timber deck to make maximum use of this area.

## **Car Park / Lecture Theatre Roof**

Seven car park spaces will be available with on-site bicycle spaces to the rear of the building on Denzille Lane. This area will also store refuse bins. The lecture theatre roof will be in the line of vision below the windows of the rear room on the ground floor. This will allow a natural eye line downward towards Denzille Lane.

# **Competence Assurance Committee Report**

### **Members**

The Competence Assurance Committee is a new committee established to implement The College of Anaesthetists of Ireland role under the Medical Practitioners Act 2007. A Forum comprising all the training bodies acts as a steering committee to ensure activation of the Competence Assurance aspects of the new Act. Each training body will have a Competence Assurance committee and the Forum acts as a liaison between the Medical Council and the committees.

The College is responsible for all Anaesthetists, ICU doctors and Pain Medicine doctors. The College will also be responsible for the competence assurance of non aligned doctors allocated to it by the Medical Council. The College on-line CME registration process has been restructured and all fellows have been contacted to encourage them to use this CME registration mechanism while it remains a voluntary process.

The Committee will coordinate and oversee CME and will work on Audit projects for The College. For the coming year the committee will work within the structures outlined by the Forum to roll out the requirements of the new Medical Practitioners Act.

# **Quality & Safety Advisory Committee Report**

### Introduction

Increasingly The College is invited to assist when adverse patient outcomes occur. We are also invited to provide assistance in other matters pertaining and related to anaesthetic standards and practice.

The College currently has no formal process for dealing with such requests. Each request is dealt with on its merits.

### **Background**

The Medical Council in the 2007 Medical Practitioners Act (MPA) has the statutory responsibility for the registration of Medical Practitioners. The Medical Council has a range of powers under the 2007 MPA to impose sanctions on Medical Practitioners. The 2007 MPA also empowers the Medical Council to use the expertise of the Training Bodies in fulfilling its role. In light of this and the desire by the Medical Council to deal with issues of this nature in a forum other than the Fitness to Practice Committee it was considered appropriate for The College to explore its role, if any, in this matter.

The Health Services Executive has responsibility for delivery of a safe, high quality service to patients and an obligation to review this service, either when a deficit is recognised or when new evidence based developments become available and drive change in practice. HIQA has a statutory role in the external accreditation and review of services delivered across the health care system. This is underpinned by legislation. The Patient Safety Commission will also have a role in ensuring patient safety.

### The College's Role

The College of Anaesthetists of Ireland has the knowledge, expertise and experience to contribute to any process described above. Its Articles of Association charge it with the responsibility of acting in the interest of public safety and in providing advice to statutory bodies. Thus, it would appear that the Articles of Association anticipate The College being involved in such a role. There is a general expectation that The College ought to play a role; however, the structures and processes are non-existent or at best very unclear at present. In light of the potential complexity of these matters, The College is contributing to the development of robust and transparent processes in conjunction with the HSE, through the Forum of Post-Graduate Training Bodies. This is an essential function of this body and will drive the development and maintenance of professional standards throughout Irish healthcare.

# **Definition of the College's potential role**

The Articles of Association of The College define its role and expertise. The College of Anaesthetists is a body which has knowledge, expertise and experience in the education, training, standard setting and evaluation of clinical and didactic knowledge of matters pertaining to anaesthesia and in matters pertaining to professionalism. The College has no role in human resource management, contract issues or HR or legal matters.

The Medical Council has the legal background, the expertise of examining medical competency issues and the statutory powers to process cases. The Medical



Council additionally has the protection afforded by the Medical Practitioners Act 2007 to afford the necessary protections. The HSE has expertise in Human Resources and employment issues.

The College accepts that it has a role to play when requested to supply advice or expertise in matters pertaining to anaesthesia, intensive care and pain medicine. The College can only supply such knowledge and expertise in an appropriate forum and process. The College acknowledges its role in relation to support of its Fellows, and will supply insofar as possible such support as required, be it advice, mentoring, up-skilling or re-training in specific areas.

# Terms of Reference for the Quality & Advisory Committee

- (1) The Committee will report to the Council of The College of Anaesthetists of Ireland.
- (2) The Committee will be responsible for reviewing all cases referred to The College, either by external agencies or by individuals.
- (3) The Committee will assess whether the CAI has a role in any proposed review process.
- (4) The Committee will outline the resources required to engage in any process.
- (5) The work of the Committee will be in line with the obligations outlined in the Medical Practitioners Act 2007.
- (6) The Committee will ensure that all indemnity issues for the CAI are agreed prior to commencement of any review process.
- (7) The Committee will work with other College Committees and external agencies to develop

- Practice Guidelines relevant to the Irish healthcare system
- (8) The Committee will provide advice in matters of professional practice and standards to Fellows and external agencies, where appropriate.
- (9) The Committee will meet bi-monthly, but may be convened for extra-ordinary meetings, if required.
